RE: Town of Columbia 2023-2024 Mill Rate if no state funding were received

The Town of Columbia's 2023-2024 budget was approved and adopted at the Annual Town Meeting on Tuesday, May 9, 2023. After the meeting, the Financial Planning and Allocation Commission (FiPAC) set the 2023-2024 Mill Rate at 25.91.

Below is a calculation of the 2023-2024 Mill Rate if the Town did not receive any state funding.
