

### TOWN OF COLUMBIA OFFICE OF THE FIRST SELECTMAN

**IMPORTANT INFORMATION ON COVID-19 VACCINES:** At the time of this publication Governor Lamont announced Connecticut will the continue age-based approach to COVID-19 vaccine eligibility; educators and childcare providers to have dedicated clinics in March.

The planned schedule is as follows:

March 1, 2021: Expands to age group 55 to 64

March 22, 2021: Expands to age group 45 to 54

April 12, 2021: Expands to age group 35 to 44

May 3, 2021: Expands to age group 16 to 34

If you're already receiving care at VA, your local VA health facility may contact you by phone, email, or text message. If you're eligible and want to get a vaccine, we encourage you to respond.


But before you provide any personal information or click on any links, be sure the call, email, or text is really from VA.

- Text messages will always come from 53079.
- Emails will always come from a va.gov email address.
- If someone calls you from VA and you don't recognize the phone number, ask for a number to call them back. Then call your local VA health facility to verify.
- Your facility may invite you to get a vaccine in different ways:
- They may invite you to a large vaccination event, like a drive-thru clinic.
- They may offer you a specific date and time to get a vaccine.
- They may ask you to schedule an appointment.

In accordance with Governor Lamont's Executive Order 7B and social distancing guidelines recommended by the CDC to slow community spread of COVID-19, meetings are physically closed to the public. We encourage residents to join via Zoom and to provide your comments and input during the meetings utilizing the "Chat" feature in Zoom, or providing comment during the Audience of Citizens/Public Comment portion of the meeting. ASSESSORS OFFICE: 2021 ASSESSMENT & REVALUATION: Connecticut law requires all real estate to be revalued for assessment purposes every five years. Towns and cities that do not adhere to the revaluation requirements will be penalized 10% of their state grants. Revaluations are required to ensure uniformity in property valuations. A complete revaluation program includes modernizing the assessment system, taking a complete description of all inventory of all property, and setting new assessed values on a current basis. Because regular assessment work must be carried on along with the revaluation program, most assessors find it necessary to seek the assistance of a private appraisal company in conducting a complete revaluation. Responsibility for final determination of value, however, remains with the assessor. For information on the assessment and revaluation please click here.

Please make sure that the envelope is clearly marked with the town department name and include your contact information on your envelope placed in the lock-box.

Work that is to be done by a contractor must include a copy of their State license, and certificate of insurance with workman's comp, and should include a signed authorization from the property owner. Inspections will be carried out by appointment only for exterior inspections as well as inspections of non-occupied structures (new construction/additions) will continue.

There is no charge for the use of this facility by Willington residents, with proof of residency. Business will be charged based on the material type and quantity. 

Important Deadlines: 3/31/21 Deadline for fuel authorizations

5/3/21 Last day that a household can apply to establish eligibility for benefits unless the household is utility heated and has a shutoff notice for its primary source of heat.

5/14/21 Last day that utility heated household with a shut-off notice for its primary heat can apply to establish its eligibility for benefits.

# ACHM Hunger Action Team's Emergency Rental Assistance Program

One-time emergency rental assistance (up to \$250) for Andover, Hebron, Columbia, & Marlborough residents whose employment income has been negatively impacted by COVID-19.



#### Important change to tax deadlines:

December 16, 2020, Governor Lamont signed Executive Order (EO) No. 9R. Section 1, Suspension and Modification of Tax Deadlines and Collection Efforts for Tax Bills That Become Due and Payable on January 1, 2021. EO No. 9R extends the grace period for the real estate, personal property and supplemental motor vehicle taxes that become due on January 1, 2021 only. What is "deferred" is not a tax but rather the last day to pay without interest. The deadline is deferred, not the tax. All taxpayers except for Landlords and escrowed accounts are eligible and are entitled to defer their payment deadline until April 1, 2021, instead of the usual 30 days.
