

### OFFICE OF THE FIRST SELECTMAN

At the time of this publication, we have as a community and a nation been dealing with the Coronavirus (COVID-19) pandemic for over a year. So much has changed for our community, but we are seeing some positive changes. More than half of CT adults are now vaccinated, CT schools are reopening, and capacity restrictions have been lifted for business and restaurants.

All Town departments are open to the public without an appointment. We ask that residents wear masks when entering the building, use hand sanitizer at the entrance, and observe social distancing guidelines. We continue to encourage residents to use on-line services and the drop-boxes at Yeoman's Hall and Town Hall for tax payments, correspondence, permits, Transfer Station stickers, dog license, etc.

The annual budget process is in full swing with the Board of Selectmen and Board of Education budgets presented to the Financial Planning and Allocation Commission (FiPAC). FiPAC is currently holding their budget workshops to discuss and deliberate on the proposed budget and will hold a public hearing to gather citizen input. After considering all input, FiPAC will recommend its proposed budget to a Town Meeting for final vote and approval.

FiPAC and Board of Selectmen meetings are being held by utilizing remote access. The Public Hearing and Town Meeting will be held at Horace Porter School gymnasium. Please check the website for dates and times.

With warmer weather Rec Park's pickle-ball, tennis and basketball courts are being fully used. I look forward to games at the new softball fields and encourage all our residents to enjoy all that Rec Park has to offer. I would like to thank the Department of Public Works for their work on the back parking lot at Rec Park over the winter. They have done a tremendous job handling the tree removal, parking lot foundation, and the preparation for final milling and topcoat. In addition, Public Works created handicap accessibility from Szegda Farm's parking lot to the garden, so all can enjoy the garden.

As Steven Everett mentioned we are now open to the public without an appointment, which is a good sign that we are turning a corner.

The latest Eastern Highlands Health District (EHHD) COVID-19 Update

reports that the total weekly case count has leveled out over the past three weeks. There is, however, still a significant risk of community transmission with most member towns at the Department of Public Health Red Alert level. Contact tracers continue to report clusters associated with, workplaces, youth sports, and transmissions linked to small social gatherings. We urge everyone to keep wearing masks and practice social distancing.

On the positive side, to date, the EHHD has administered 8,100 doses of COVID-19 vaccine. As of April 14th, 47% percent of the total EHHD population has received one dose of vaccine.

**The Salmon River Watershed Partnership (SRWP)** will be undertaking a new venture in 2021: Creating a long-term vision for a path forward towards sustainable management and funding.

Columbia is a supporting watershed partner with SRWP. SRWP manages watershed resources, focusing on water quality, land-use management and preservation, and outreach education. Funding for the Partnership allows for the hiring of a part-time watershed coordinator, summer interns, monitoring equipment and outreach materials.

In the SRWP 2021 Annual Newsletter, Pat Young, Watershed Coordinator explained their new vision; "In 2008, a steering committee, the Salmon River Watershed Partnership, was formed when The Nature Conservancy was awarded a Long Island Sound Futures Fund Grant to conduct a comprehensive land-use evaluation for the watershed towns. Upon completion of that project, it was agreed that the Partnership should be continued, and municipal funding has provided for a part time watershed coordinator and summer interns who, along with many volunteers, conduct water monitoring, outreach and education, resource mapping and provide other municipal project support as needed.

With a higher emphasis on working regionally and collectively to protect local rivers and water quality and to ensure long-term viability, the steering committee is entering a new

phase of long-term planning. With funds already secured, the committee, along with town and community representatives, will begin work with the same firm that conducted the earlier study, Horsley-Witten Group, to identify long term goals, committee management options and funding opportunities."

ASSESSORS OFFICE: Town of Columbia 2021 Revaluation eQuality Valuation Services, L.L.C. of Waterbury Connecticut, has been contracted to assist the Assessor in conducting the October 1, 2021 revaluation of all properties in Columbia, as mandated by state law. A representative of eQuality will soon begin data collection in your neighborhood. Under the Assessor's supervision, eQuality collects and analyzes information about all properties. An important part of the valuation process involves measuring the outside and listing interior features of each structure by a representative of eQuality.

During the COVID-19 pandemic, we want to ensure the safety of both our residents and the eQuality representatives. The data collector will perform only an exterior inspection and take a photo of the front of each building. At this time, there will be no interior inspections. If you would like an interior inspection, please contact the assessor directly at <a href="mailto:mlavallee@columbiact.org">mlavallee@columbiact.org</a>. If you are not at home, in the next few months, we will mail you a property data questionnaire. Please review your information and return the form in the pre-paid envelope. We appreciate your cooperation in this process. All representatives will carry photo identification and the original letter of introduction signed by the Assessor. Homeowners are encouraged to ask for identification from the data collector. Their vehicles are registered with the Columbia Resident State Trooper's Office.

beginning Tuesday, June 1, 2021. Reservations for activities begin May 17th. The activities will only be available 3 days per week to start. Tuesdays, Wednesdays, and Thursdays from 8am to 3pm. The Beckish Senior Center & Transportation Program will remain open Monday thru Friday 8am to 3pm. We will gradually open to 5 days a week in the coming months. We are excited about welcoming people back into the building and we will be reopening slowly, with caution. Our population is still the most at-risk group for contracting COVID-19 and complications arising out of being infected. Safety, for our members and our staff, will remain our highest priority. It is not only our biggest concern; it is our responsibility. To reopen, we must abide by state guidelines for three different sectors (per the Governor): Senior Centers, Indoor Recreation and Fitness Centers plus the Eastern Highlands Health District. We, more than anyone, wish we did not have to do this, but we are determined to follow the guidelines to keep everyone safe and healthy.

**BECKISH SENIOR CENTER CONTINUTED:** Although it will not be the same Senior Center you left on March 10th, we are excited to offer opportunities for people to see each other and have fun.

Can I just stop by the Senior Center any time I want? Unfortunately, NO. Per the state guidelines, individuals must make an advance "reservation" to attend a program or service at the Senior Center. This is necessary for contact tracing in the event someone tests positive for COVID-19 and to keep track of the numbers of people in the building. For instance, if you want to speak with Margaret or Lisa our Transportation Dispatchers, you must call for an appointment. If you want to use our exercise equipment, you must call in advance to "register" to workout. If you want to play billiards, you must call in advance to reserve the pool table to play. If you want to take a fitness class, you must call in advance to reserve your spot. Each activity will have maximum attendance limits due to social distancing, the size of the room and the activity. Health department guidelines will limit your time at the Center to 2 hours.

MASKS ARE MANDATORY. If you are unable to wear a mask, please call Bernadette at the Senior Center and we will try and make alternative arrangements for you to participate in programs or services virtually. Masks must be worn covering the nose and the mouth completely. Masks with ventilators are not acceptable, unless a paper disposable mask is worn over the ventilator mask.

Please call or email ahead to verify permit fees (by check only, made out to Town of Columbia), or to address other questions. Work that is to be done by a contractor must include a copy of their State license, and certificate of insurance with workman's comp, and should include a signed authorization from the property owner. Inspections will be carried out by appointment only for exterior inspections as well as inspections of non-occupied structures (new construction/additions) will continue.





**TOWN CLERKS OFFICE:** Due to the continuing Corona virus pandemic, the need for social distancing and to limit the number of people in Town Hall, the following options will be in place with regards to how to purchase your transfer station sticker and license your dog.

**TRANSFER STATION PERMIT STICKERS:** Transfer station permit stickers for 2021 will be available for purchase May 1, 2021. This year, to purchase a transfer station sticker, please go **ONLINE.** or **MAIL** us your application or use the **DROP BOX**. Remember to make your check payable to: **Town of Columbia** and **INCLUDE A STAMPED SELF-ADDRESSED ENVELOPE** for mailing back your stickers.

**DOG LICENSING:** JUNE is dog licensing month. If your dog's rabies vaccination has expired, please provide us with a copy of their current rabies vaccination certificate. If your dog has been spayed or neutered, include a copy of the veterinarian's certificate as well. The license year for your dog runs from July 1, 2021 to June 30, 2022.

PLEASE NOTE – If your dog's rabies vaccination expires in the month of JUNE, you will not be able to renew the dog's license for the new year (which begins on July 1, 2021) until we receive a current rabies certificate.

Due to the continuing Corona virus pandemic and the need for social distancing, the following

options will be available with respect to licensing your dog in Columbia. We will be accepting registrations **BY MAIL or BY DROP BOX** to limit the number of people in Town Hall. Remember to make your check payable to: **Columbia Town Clerk** and **INCLUDE A STAMPED SELF-ADDRESSED ENVELOPE WITH THE APPROPRIATE AMOUNT OF POSTAGE** for the return of your dog's new tag. Please contact us at 860-228-3284 if you have any questions.
