Spring is here and that means its time to start getting outdoors and enjoying all that Columbia has to offer.

Recreation Park: The new pavilion at Rec Park has already been used for several Recreation Department events. Summer Camps will be starting up (2-4-1, Vale Soccer Camp, and Holowaty Columbia Baseball Camp), and baseball and softball season will be beginning soon.

The 9-hole Disc Golf course is expected to be completed in early June and the Tennis and new pickle ball court will be completed in early July. The existing pickle ball court will be completed by the end of the first week in May. The fencing for the pickle ball court was taken down to accommodate work on the tennis courts and will be put back up so people can use the court again.

Town Beach: Beach passes are now available to purchase. Please visit the <u>Recreation</u> <u>Departments</u> page to purchase your beach passes, or stop in and see Debbie Fiske, Recreation Director, or Anyka Fagen, Assistant Recreation Director at the office located at the beach.

The pavilion at the beach sustained damage from a tree falling on it over the winter causing too much damage for the pavilion to be repaired. Currently architectural drawings are being drawn up and the estimated completion will be at the end of the summer season.

4th of July Parade: Just a reminder the The Town of Columbia and the Columbia Lions Club are sponsoring the Annual July 4th Independence Day parade here in Columbia. The theme for this year's parade is "Let Freedom Ring". The Lion's club has increased the cash prizes that will be awarded for the floats that best represent this year's theme! First prize is \$250, second \$150,



and third \$100. The parade will commence at 10:00 am on the morning of TUESDAY, JULY 4TH 2023. The parade route is approximately 1.1 miles long.

ASSESSORS OFFICE: The Renter's Relief program will begin April 1 and will run through October 1st. You will need proof of rent payments and utilities paid in the 2022 calendar year.

HOMEOWNERS ELDERLY RELIEF PROGRAM

If you filed for the Homeowners elderly relief program in 2022, you do not need to file this year. Persons who filed in 2021 will need to apply by **May 15th.** Please call our office and we will instruct you on what you need to supply our office and how to get that to us.

Motor Vehicle Adjustments: In order to have a motor vehicle bill adjusted we need two forms of proof because the tax is a car tax not a road tax.

- The first is a copy of your motor vehicle plate return receipt
- The second is something proving you got rid of the vehicle. For a list of accepted proofs look on the assessor's website or call the office.
- If you traded a vehicle and kept the same plate do not bring us any documentation because DMV will automatically process the adjustments.

Income and Expense Forms: Connecticut General Statute 12-63c requires all owners of rental real property to annually file an Income and Expense form with the Assessor's Office by June 1st.. The information filed and furnished with this report will remain confidential and is not open to public inspection. Any information related to the actual rental and operating expenses shall not be a public record and is not subject to the provisions of Section 1-19 (Freedom of Information) of the Connecticut General Statutes. All properties that are rented or leased, including commercial, retail, industrial, land and residential properties, except "such property used for residential purposes, containing not more than six dwelling units and in which the owner resides" must file and in the case of a non-residential property that is partially rented and partially owner-occupied.

In accordance with Section 12-63c(d), of the Connecticut General Statutes, as amended, any owner of rental real property who fails to file this form or files an incomplete or false form with intent to defraud, shall be subject to a penalty assessment equal to a Ten Percent (10%) increase in the assessed value of such property.



FIRE MARSHAL:

House Fires

If you happened, to be unfortunate and have a fire in your home, here are a few safety tips to help you in preparation for this tragic event.

- 1. Get out of the home.
- 2. Notify all other occupants and account for everyone once outside.
- 3. Call 9-1-1 and give the dispatcher good information.
- 4. Never re-enter the dwelling for anything.
- 5. When the Fire Department arrives, communicate if everyone is accounted for and any special hazards, i.e., guns, ammunition, propane gas or lost pets.
- 6. Remain calm.

ELDERLY AND DISABLED PROPERTY TAX RELIEF


DEADLINE: MAY 15, 2023!!

Elderly and disabled homeowners who qualify can apply for reduced property taxes on their homes until May 15, 2023. This year's income limits are \$40,300 maximum for an individual and \$49,100 for a couple. All gross income is counted including Social Security benefits. Documents you will need: Signed 1040 Federal Tax form (if you file); Social Security Statement (SSA-1099); Pension Statement; Bank Interest Statement; Any other Income. Applicants must be disabled or 65+ as of 2022. Contact the Columbia Assessor's office at 860-228-9555 to apply. RENTER'S REBATE

Did you rent an apartment in 2022? Are you 65 or totally disabled? Income limited to \$40,300 for an individual, \$49,100 for a couple. Documentation needed includes all income for 2022 which includes your 2022 1040 form and Social Security 1099 form or if you do not file taxes all 2022 1099 forms and proof of what you paid for rent and utilities for 2022. Deadline to apply is October 1, 2023.







TAX DEPARTMENT: Real Estate taxes on the October 1, 2021 Grand List that were due July 1, 2022 and January 1, 2023 that have not been paid in full by May 31, 2023 will have a continuing tax lien filed in the land records as required by law.

Any delinquent tax not paid by June 30, 2023 will be listed by name and amount in the annual Town Report.

Regular office hours for the TAX OFFICE: Monday through Wednesday 8:00-2:00, Thursday 10:00-6:00 and closed on Friday. *The Tax Office has extended hours in July and August 1, 2023: Monday through Wednesday 8:00-4:00, Thursday 10:00-6:00 and Friday 8:00-12:00.*

Drop boxes for payments and correspondence are located at the right side of the entrance of the Town Hall and in front of Yeoman's Hall. The drop boxes are emptied at 8:00AM each weekday, weekend tax payments are processed on Monday. Please be aware that tax payments put in the drop box after 8:00AM will be processed the next day the Tax Office is open.

You can view and pay your tax bills online; Go to www.columbiact.org and click on the Pay Taxes Online tab on the home page. On the next page click on the View/Pay button (square) to go to a search screen. Type your last name, space, first initial of your first name (as is written on the bill). The service fee for online payments are as follows: 95 cents to use a Bank account and 2.95% for PayPal, Credit and Debit cards. Effective 6/19/23 the fee for PayPal, Credit and Debit cards will increase to 2.99%. The Bank account (EFT) fee will remain at 95 cents. To look up your 2022 tax payments go to www.columbiact.org. On Columbia's home page, click on the Pay Taxes Online tab. The directions will be listed on the next page. Tax bills for the 2022 Grand List will be mailed at the end of June 2023 with a due date of July 1, 2023. The last day to pay without a penalty will be Tuesday August 1, 2023. Bills will be available online on July 1, 2023. By law, this office uses the USPS postmark as the payment date. If you are waiting until the last few days to pay, it is recommended that you have your envelope hand stamped in the Post Office. Putting your envelope in a blue postal box may not guarantee an on-time postmark.

If you are coming to pay in person in July and on August 1, 2023, please be aware that there may be a line and you may have to wait for service. Please plan your visit accordingly.

TAX DEPARTMENT (CONTINUED):For those seeking an immediate clearance for DMV due to delinquent Motor Vehicle taxes please contact the Tax Office at 860-228-0230 or taxcollector@columbiact.org for information on the process. Paying the tax bill online does not clear you immediately at DMV. You will need to contact the tax office during tax office hours for assistance.

TOWN CLERK'S OFFICE: TIt is business as usual in the Clerk's office for all those services that you might need - Recording and Searching of Land Records and Maps, Certified copies of Vital Records, Marriage licenses, Fishing and Hunting licenses, Dog licenses, Transfer Station stickers, etc.

TRANSFER STATION PERMIT STICKERS: Transfer station permit stickers for 2023 (Effective June 1, 2023), will be available for purchase May 1, 2023.

Applications for Transfer Station stickers can be sent to us by MAIL or can be dropped off in the large white DROP BOX located outside the doors to Yeoman's Hall. Make your check payable to: Town of Columbia and INCLUDE A STAMPED SELF-ADDRESSED ENVELOPE for mailing back your stickers.

PARADE MARCH ORDER: This will be established by the parade Committee (considering strategic positions for Police & Fire Units) on the morning of the parade.


PARADE KICK-OFF: Promptly at 10:00 a.m.

Who knew that using flood lights, outdoor lighting and streetlights could be dangerous to wild animals, especially migrating birds? We thought night lighting keeps us safer. Research indicates It does not. Meredith Borges, Yale Divinity School student, and Co-Chair of "Lights Out, CT", gave a talk explaining the hazards of night lighting at the Saxon B. Little Library in January. Her mission was to let people know how lighting has harmed a multitude of nocturnal animals, pollinator insects, but especially migrating birds. Most importantly, she presented some simple solutions to help mitigate the significant loss of bird populations due to light pollution and made suggestions how we might preserve the night sky.

How are birds damaged by light? 80% of the world's birds migrate two times a year over many days as part of their normal life cycle, and 60% of those migrate at night. We humans depend on roadmaps and GPS to navigate, but birds have evolved a navigation system that relies heavily upon cues from the bright stars and the moon. Night lighting creates a "sky glow" that obscures those cues. This disorients migrating birds resulting in an early- morning landings in places they would normally not land. This has two negative outcomes. Taking even a short "wrong turn" or detour on a journey thousands of miles long can critically deplete the fat stores upon which the birds rely to fuel the journey to their breeding grounds. Additionally, when disoriented birds land in brightly lit urban or suburban areas, they do not land in places that are safe for them. The worst threat to them is caused early in the morning when they crash into large windows in brightly lit buildings, or when they land in places where they are unlikely to find food, they need to finish their journey. Ms. Borges explained that research shows the population of migrating birds, including our warblers, juncos, orioles, and hummingbirds, has decreased by 25% since 1970.

Thanks to new awareness of the harm from night lighting, Connecticut is one of several states that has proposed bills that would require state-owned buildings to reduce or change lighting from 11pm to 6am. What can you, as private citizens do to protect pollinator insects and especially our birds right away? You and I can turn off floodlights, turn off decorative lighting, or reorient lighting downward onto pathways. Where night lighting might be deemed essential, motion detectors would light up only momentarily when needed. The easiest, most economical thing to do is simply turn off outside lights. With a restored dark night sky, we can help protect endangered birds and we humans might sleep better too.
