

A MESSAGE FROM EVERSOURCE - How to Take Control of Energy Costs: As it did last winter, the cost of energy supply is expected to once again increase when we transition from summer to winter rates on January 1. We're encouraging customers to take control of their energy costs by shopping for a third-party supplier at <a href="EnergizeCT.com">EnergizeCT.com</a>.

We recognize the financial burden that high energy prices place on our customers, especially as the costs of other goods and services have increased. We're reaching out to all our stakeholders to make them aware of the likely increase and encourage them to take action and help make their residents and constituents aware of the ways they can shop, sign up, and save.

We've launched an educational campaign to reach as many people as possible through digital advertising, media and social media, customer emails, billboards, and website messages to encourage customers to compare rates offered by third-party suppliers on <a href="EnergizeCT.com">EnergizeCT.com</a>. Eversource customers who've never shopped before can find help navigating the process by going to <a href="Eversource.com/supplier">Eversource.com/supplier</a>.



As you know, Eversource does not produce electricity. We purchase power for our Standard Service rate on behalf of our customers on the open market and directly pass those costs on without any markup. International factors continue to affect the seasonal winter cost of natural gas, which is used to produce roughly half of New England's electricity. While we do expect the electric supply price to rise this winter, it is not expected to increase as much as it did last winter. We'll file proposed rates with PURA in mid-November, and the approved new rates will take effect January 1, 2024, for customers on Standard Service.

to learn about the other programs and services that are available, including:

- Our **Budget Billing Plan** helps avoid seasonal spikes on their energy bill by letting customers pay a fixed amount each month based on their average annual usage.
- The Matching Payment Program can lower the amount customers owe on energy bills. For every dollar they pay and every dollar they receive from the Connecticut Energy Assistance Program, we will subtract a dollar from the amount owed.
- The New Start Program forgives overdue balances for electric customers as on-time monthly budget payments are made. (For example, if your budget payment amount is set at \$150 per month and your past due balance is \$1,200, for every month you make your required \$150 payment towards your bill, we will reduce your past-due balance by \$100.)
- **Payment Plans** are available to all customers to help pay their past-due balance over time.
- A new Low-Income Discount Rate will take effect December 1, which can give
  customers with financial hardship either a 10% or 50% discount off their electric
  bill per month. Customers can qualify to receive the discount based on household
  income or receipt of a public assistance benefit. For example, if a customer has a \$100
  monthly bill, it would be \$10 less if they receive a 10% discount or \$50 less if they
  receive the 50% discount.
- Residential customers are encouraged to take advantage of seasonal energy-saving tips, offers, programs and rebates to help reduce energy use leading up to and during this winter.

#### **AWARENESS, PREVENTION AND IMMUNIZATION**

Respiratory infections peak in the fall and winter months and prevention is key to slowing the spread and staying healthy. Prevention tools you can use this season:

- Stay up-to-date with vaccines: flu and COVID vaccines are updated for current strains and recommended for everyone; RSV is a new vaccine for special groups (very young and over 60)
- Stay home when sick (and the first 5 days after symptoms start for COVID)
- Wash your hands frequently
- Remember respiratory etiquette (cover your cough, preferably not with your hands)

#### A NOTE FROM THE EMERGENCY MANAGEMENT DIRECTOR:

TURN YOUR HEADLIGHTS ON: Please turn on your vehicle's headlights during the day when there is bad weather occurring. Rain, snow, or fog can make the visibility of your vehicle less than desired, especially to larger trucks, buses and vans who rely on their mirrors to see other motorists. If your windshield wipers are on don't rely on your day running lights (if vehicle equipped) to increase your visibility but turn



your headlights on, which will also turn your rear lights on giving a full circle of illumination. Connecticut law requires motor vehicles to display their headlights during any periods of precipitation.



### **COLUMBIA LAKE FISH SURVEY: CTDEEP**

will be conducting Statewide Lake and Large River fish survey. DEEP will arrive tomorrow evening, November 2nd between 5:30 & 5:45 PM in Columbia Lake. They anticipate starting the sampling at 6:15 and it is a four hour journey. For more information on the warmwater fish monitoring program please visit the CT DEEP website.

"Connecticut anglers spend over three million trips per year fishing for largemouth and smallmouth bass and other warmwater fish species (U.S. Fish and Wildlife Service, 2011). Prior to the 1980s, it had been 25 years since a major statewide lake and pond fisheries survey had been conducted. Therefore, the Connecticut DEEP Fisheries Division (FD)



implemented a statewide night boat electrofishing survey of nearly 200 lakes, ponds and large rivers between 1988 and 1995. This survey provided fisheries management staff with invaluable information on fish populations throughout Connecticut. However, lakes are dynamic systems and information on parameters such as fish population structure, growth and mortality must be current to make informed management decisions."

### **Voter Registration:**

- The last day to register to vote is Tuesday, October 31, 2023.
- Register online at <u>voterregistration.ct.gov</u>, stop in the Town Clerk's office during normal business hours, or contact the Registrars of Voters.
- The Registrars of Voters will be holding a voter registration session in Yeomans Hall on Tuesday, October 31st from 9am – 8pm. ID and proof of residency required.



• If you miss the registration deadline, Election Day Registration will be available at Yeomans Hall on November 7th, 6am-8pm. ID & proof of residency will be required.

#### Absentee Ballots:

- Absentee Ballots are available now through close of business on November 6th. To obtain an Absentee Ballot, you must first fill out an application. You can find an application on the **Registrars of Voters website**, or contact the Town Clerk at (860) 228-3284.
- Completed Absentee Ballots must be received by 8pm on November 7th. They can
  be returned via mail, Ballot Drop Box outside Town Hall, or to the Town Clerk's office.

#### **PERMITS**

If you have taken a building permit out from 10/1/2022 to 9/30/2023, please send pictures with a paper stating the date on it, to show that either the work has not been performed, or at what status the work currently is. This includes work that was COD. Please submit pictures to mhawley@columbiact.org by November 1, 2023. This is in lieu of physical inspection. If you prefer a visit just email me and we can schedule a date and time. Please be patient with my reply as I am inundated with responses this time of year. I will reply.

#### **PERSONAL PROPERTY**

This notice is to remind all taxpayers who file a declaration for personal property to please do so no later than November 1st annually. If not filed in a timely manner, per state statute a 25% penalty shall be applied. If you own a business or have unregistered motor vehicle(s) that are not currently on our list, please let us know and we will email, fax or mail you a declaration.

#### **SOCIAL SERVICES:**

**NEW: CT ELECTRIC DISCOUNT RATE:** With the winter season approaching, a reminder that there are resources for heating assistance:

A bill discount will be available for residential electric customers who qualify starting in December 2023.

You must have financial hardship status on your electric account. To apply visit **Eversource** 

There are two tiers of discount (10% or 50%) depending on your annual household income or receipt of a public assistance benefit.

#### **HOW TO GET THE CONNECTICUT 10% DISCOUNT RATE**

### Step 1: Apply for or Verify Your Financial Hardship Status on Your Electric Account

There are two ways you can apply for or verify your hardship status. You can either provide Eversource with receipt of eligible public assistance benefits, or submit proof of income documents that verify you meet the income eligibility requirements.

Public Assistance Benefit Qualifiers for the 10% Discount

You must have at least one person in the household that can show receipt of a public assistance benefit from one of the following programs.

- Medicaid or Access Health; HUSKY B
- State HUSKY B
- Connecticut Energy Assistance Program (CEAP)
- Section 8 Housing, Rental Assistance Program
- Medicare Savings Programs (MSP)
  - o Additional Low-Income Medicare Beneficiary (ALMB)
  - o Special Low-Income Medicare Beneficiary (SLMB)

### **SOCIAL SERVICES (CONTINUED):** Income Eligibility Requirements

If you don't receive one of the public assistance benefits listed above, the following guidelines determine how much all household members over 18 can make to be at or below **60% of the state median income** and qualify for a 10% discount on your electric bill.

If you meet these income requirements, you must submit one of the following verification documents for all household members over 18.

- Unemployment benefit letter or most recent bank statement
- Employment (last four weekly pay stubs, last two bi-weekly paystubs, last monthly paystub)
- Self-employment (most recent year 1099 Tax Form)
- Social Security benefit letter
- Child support, pension, retirement, or other benefit letter or most recent bank statement showing direct deposit

#### **Step 2: Submit Documentation to Eversource**

After confirming you receive one of the eligible public assistance benefits or meet the income eligibility requirements, you may submit your documents securely in several ways.

- Log in to your account to <u>upload your documents</u>.
- Send them via U.S.P.S. mail at Eversource, Attn: Credit Dept., P.O. Box 270, Hartford, CT 06141.
- Submit documents via fax at 866-438-6476.
- Call us at 800-286-2828.
- Contact your local <u>Community Action Agency.</u>
- Eversource will review and verify your information within 10 business days. If you are eligible, you will start to see a discount on your bill in December 2023.

#### **How to Get the Connecticut 50% Discount Rate**

Starting in December 2023, you may be eligible for a 50% discount on your monthly electric bill if you have a financial hardship status on your electric account. For example, if you have a \$100 monthly bill, it would be \$50 less.

### **SOCIAL SERVICES (CONTINUED):**

### Step 1: Apply for or Verify Your Financial Hardship Status on Your Electric Account

There are two ways you can apply for or verify your hardship status. You can either provide Eversource with receipt of eligible public assistance benefits, or submit proof of income documents that verify you meet the income eligibility requirements.

Public Assistance Benefit Qualifiers for the 50% Discount

You must have at least one person in the household that can show receipt of a public assistance benefit from one of the following programs.

- Supplemental Security Income (SSI)/Social Security Disability Income (SSDI)
- Temporary Assistance for Needy Families (TANF)/Temporary Family Assistance (TFA)
- State Administered General Assistance (SAGA)
- Department of Social Services State Cash Assistance, State Supplement
- Women, Infants and Children (WIC)
- Supplemental Nutrition Assistance Program (SNAP)
- Medicaid or Access Health; HUSKY A, C, D
- State HUSKY A
- Refugee Cash Assistance and Refugee Medical Assistance
- Connecticut free or reduced lunch program
- Head Start
- Medicare Savings Programs (MSP)
  - o Qualified Medicare Beneficiary Program (QMB)

#### Income Eligibility Requirements

If you don't receive one of the public assistance benefits listed above, the following guidelines determine how much all household members over 18 can make to be at or below **160% of the federal poverty guidelines** and gualify for a 50% discount on your **electric bill.**

### **SOCIAL SERVICES (CONTINUED):**

If you meet these income requirements, you must submit one of the following verification documents for all household members over 18.

- Unemployment benefit letter or most recent bank statement
- Employment (last four weekly pay stubs, last two bi-weekly paystubs, last monthly paystub)
- Self-employment (most recent year 1099 Tax Form)
- Social Security benefit letter
- Child support, pension, retirement, or other benefit letter or most recent bank statement showing direct deposit

#### **Step 2: Submit Documentation to Us**

After confirming you receive one of the public assistance benefits or meet the income eligibility requirements, you may submit your documents securely in several ways.

- Log in to your account to <u>upload your documents</u>.
- Send them via U.S.P.S. mail at Eversource, Attn: Credit Dept., P.O. Box 270, Hartford, CT 06141.
- Submit documents via fax at 866-438-6476.
- Call us at 800-286-2828.
- Contact your local <u>Community Action Agency</u>.

Eversource will review and verify your information within 10 business days. If you are eligible, you could start to see a discount on your bill in December 2023.

TAX OFFICE: Don't forget!! The second installment of the Real Estate, Personal Property and the Supplemental Motor Vehicle taxes will become due on January 1, 2024. The last day to pay without a penalty is February 1, 2024. Bills are not sent for the second installment, please put a reminder on your calendar! Please feel free to leave payments or correspondence in the drop box at the right side of the entrance of the Town Hall or in the drop box in front of Yeoman's Hall. The drop boxes are emptied at 8:00AM each weekday; weekend tax payments are processed on Monday. Please be aware that tax payments put in the drop box after 8:00AM will be processed the next day the Tax Office is open (see hours below).

Regular office hours for the <u>TAX OFFICE</u>: Monday through Wednesday 8:00-2:00, Thursday 10:00-6:00 and closed on Friday. The Tax Office has extended hours in the month of January and February 1, 2024: Monday through Wednesday 8:00-4:00, Thursday 10:00-6:00 and Friday 8:00-12:00.

Columbia residents can view and pay taxes online, service fees for tax payments apply, .95 cents to use a bank account and 2.99% for credit and debit cards.

- Go to <u>www.columbiact.org</u>
- On the home page click on the pay taxes online tab.
- On the next page click on to view/pay tax bills.
- The search criteria will need to be entered exactly how the tax bill is written. Enter the last name, a space, and then the first initial of the first name.

You can also utilize this site during income tax time to look up your payment history. Locate your bill using the instructions above, then hover over the icons in the option column and click on the one that says tax payment history. You will also find written instructions on the pay taxes online page. Absentee ballots can be returned in the Official Ballot Drop Box located outside the doors to the Administrative Offices entrance to Town Hall.
