<i>On or after October 1, 1997 no resident of the state, person owning real property in the state or person owning a vessel in the state, shall operate on the waters of the state a vessel which is required to be registered or numbered in the state unless such person has obtained a Safe Boating Certificate.</i>

Further, the undersigned assumes all responsibility for, and all risk of, damage or injury that may occur to the undersigned or his property as the result of such mooring.

Applicant acknowledges that to the best of his/her knowledge all information submitted on this form is true and correct and that submission of incorrect information, whether intentional or unintentional, may result in forfeiture of the assigned mooring.

Board of Selectmen Policy states that: *The only boat which may be attached to any Town of Columbia boat mooring is the boat described in the corresponding application form. Mooring-holders are not authorized to share, sublet, or transfer moorings, or allow use of the mooring by any other party. All moorings remain the property of the Town of Columbia under the authority of the Board of Selectmen, and are subject to revocation.* Signature below indicates that the applicant is aware of and agrees to comply with the policy.
